RMM MEDIA POLICY

Rocky Mountain Motorsports (RMM) issues media credentials on a per event basis. Media Credentials will NOT be issued on the day of the event. Please submit credential requests no later than seven (7) days prior to an event. You may apply for multiple events in a single request (Maximum of 3 per request). Submissions are to be sent to info@rockymotorsports.com.

Rocky Mountain Motorsports reserves the right to limit the number of credentials granted, as well as to revoke credentials at any time for any reason.

Being granted RMM media credentials gives you limited, non-exclusive opportunities to photograph/video events. Please note that any photo or video taken while on the property will be considered the property of RMM and can be requested by RMM at any time for no financial return. RMM will provide photo credit if images provided are used.

Recognized media include existing television, radio, print or web personnel. Free-lancers and internet sites with no prior experience are recommended to apply for credentials fourteen (14) days in advance and include a written explanation of what the material will be used for. Possible fees may apply and will be determined on an individual basis. Media product from the property should not imply an endorsement or sponsorship between a third party and RMM, its participants, staff, or partners.

In the event of Private Rentals where the renter has designated media personnel. Renters are responsible for identifying personnel to RMM and they will be given priority for credentials. All freelancer and non-designated media persons must receive sign off from both RMM and the Renter.

MEDIA RULES

All Media Personnel MUST abide by the following rules. Failure to do so will result in credentials being revoked, and possible removal from the property. NOT KNOWING IS NOT AN EXCUSE.

1. All media granted access to restricted areas must have credentials
2. All media on the property MUST sign the waiver
3. All media in restricted areas must wear close-toed shoes and a high-visibility safety vest
4. All media in restricted area must stay in designated zones (See Map)
5. All media in restricted areas is to have a radio and be aware of the operations of the track—never turn your back to a moving vehicle
6. All media is to perform their work in a manor that will not cause distraction or any additional risk to participants or themselves
7. All media wanting to cross the track or change locations that requires leaving designated zones may only do so when the track is cold and with the express permission of the Track Marshal
8. All media who has received permission temporarily to be outside of designated areas must relocated in a timely manner and inform the Track Marshal when they are clear of the track. Any personnel causing delay to the track operations may be fined
9. In the event of an incident remain in designated zones, do not cross the barriers until expressly told to do so by the Track Marshal or Operations Manager. All media regarding an incident is to be held until approval from RMM is given for release

MEDIA POLICY

DRONE OPERATION AT RMM

Drone operators must apply for media credentials.

Drones can only be flown at RMM when they meet the following criteria:

- Proof of Drone Pilots License—regardless of drone size
- Proof of Drone Registration
- Proof of insurance with a minimum of \$5,000,000 liability with Rocky Mountain Motorsports listed as a named insured
- Drones use must abide by all operating laws as well as the RMM media rules
- Drones must not be flown directly over the surface of the track
- Drones must be flown at a height to not cause distraction to participants
- Drones must be safely landed in cases of an incident
